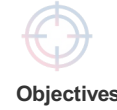

Incurred Cost Reporting

The incurred cost reporting (also known as the Incurred Cost Submission or ICS) is the annual reconciliation of actual costs incurred by a government contractor. The requirement to submit an ICS is found in Federal Acquisition Regulation (FAR) Clause 52.216-7, Allowable Cost and Payment. If this clause is included in one of your contracts, you are required to submit an ICS. Late submissions can be subject to a unilateral decision by the Contracting Officer (CO) to apply a decrement factor which will reduce reimbursement of incurred costs. Project accounting and incurred cost reporting involve segregating, analyzing, and reporting direct and indirect costs in detail to generate properly formatted incurred cost submissions with greater automation.

The Incurred cost reporting component of CIS-GovCon for A&D has the following capabilities:

Ensures version authenticity by generating a unique QR code for every schedule.

Government property includes all property owned or leased by the government including government-furnished and contractor-acquired property, and material, equipment, special tooling, special test equipment, and real property. While managing government property, the contractor must have a system of internal controls to manage (control, use, preserve, protect, repair, and maintain) government property in its possession. The system shall be adequate to satisfy the requirements of *FAR 52.245-1 – Government Property Definition*, *FAR – Part 45 – Government Property*, and *DFARS – Part 245 – Government Property* compliance standards.

The Government & Customer Property component of CIS-GovCon for A&D solution is built to meet all FAR 52.245-1 compliance standards. It addresses all aspects of managing government property from acquisition, receipt and identification, physical inventory tracking, subcontractor control, reports, forms and labels DD1149, preventative maintenance, Unique item identification (UID) of the property record, and property contract closeout.
